Complete the online Flu Shot Registration Form

To get started, just go online to healthpartners.com/employer and then scroll down to click on "Worksite Flu Shots." Click on the "Employer Registration" link to fill out the form or scroll down to print out the printable version if you'd prefer to fax or mail in the form. On the registration form, in addition to filling out your contact information and details, you can indicate:

- If you'd like to offer the program to your HealthPartners covered employees, HealthPartners covered employees and their dependents or to all employees. The cost for nonmembers may vary by vendor and location. The CDC recommends all people under the age of 18 get a flu shot – the minimum age for the on-site clinic varies by each of our vendors. Please note if you are interested in including dependents. (An employee who receives HealthPartners coverage from a spouse or significant other through a different employer group is also eligible.)
- Your preferred flu shot vendor, if you have one.
- If you want to add multiple locations for the on-site clinic.

Designate a contact person

Once you're registered, our vendor will work with your contact to schedule the flu shot clinic(s). The vendor will let you know of any minimum shot requirements for each clinic site. You will need to provide necessary supplies (tables, chairs and wastebaskets) for the nurses.

Assist your employees at the on-site clinic

All that's left to do is to encourage your employees to attend the on-site clinic. On the day of the clinic, your employees will need to fill out the employee consent forms and must supply their HealthPartners member number to ensure coverage.

An on-site flu clinic encourages your employees to get the flu shot, which helps them stay healthy and productive.
