

## HealthPartners TCRRV™ Online License Agreement

1. The term "**HealthPartners® TCRRV™ Tool**" or "**Tool**" means the innovative, patented\* relative resource value look up algorithm and associated measurements, quality grids, property, data, content, information, technical specifications, user guides, implementation materials, product fact sheets, data set specifications, concepts, analytical methodologies, computer software, information management systems, proprietary forms of data organization and reports, background materials, orientation workshop materials, education materials, and titles, whether or not confidential, and all enhancements, modifications, improvements and derivative works thereof, which is used to establish and assign a relative resource value related to every billable healthcare service delivered by a particular healthcare provider for the purpose of normalizing price and determining total care resource use. \*The Tool is protected by U.S. Patent Number 7,831,443 and U.S. Patent Number 8,332,235.
2. HealthPartners, Inc. ("**HPI**") hereby grants you a non-exclusive, non-assignable, non-transferable, revocable, royalty-free, license to use the Tool solely for your own internal, non-commercial use and benefit. You may not provide the Tool to any third party, including, but not limited to, software vendors and consulting firms (each a "**Third Party**") for the commercial benefit of a Third Party (the "**Prohibited Purpose**"). Notwithstanding anything in this provision to the contrary, you may provide the Tool to a Third Party consulting firm for the sole purpose of allowing such Third Party to assist you with the implementation of the Tool on your behalf; provided, however, that you and such Third Party have executed the Supplementary Agreement attached hereto as Exhibit A, whereby the Third Party agrees not to use the Tool for the Prohibited Purpose. Any updates and edits to the Tool are provided at our discretion. All such updates and edits will be considered part of the Tool.
3. The Tool is owned by HPI or one of its affiliates, subsidiaries, or other related organizations. HPI reserves all rights to the Tool except those that we specifically give to you in this Agreement. Nothing in this Agreement shall convey to you any further rights, title or interest in and to the Tool.
4. You may not reproduce, modify, adapt, translate, reverse engineer, decompile, disassemble, create a derivative work based on, sell, transfer, disclose, rent, license, or sublicense, in whole or in part, the Tool without our written consent. You will not remove, alter, cover, obfuscate, or modify any patent, copyright, trademark or other proprietary notice from any copy of the Tool, without HPI's written consent.
5. Subject to the limitations contained hereunder and our rights in and to the Tool, you will own all data and output generated by you using the Tool in performing analysis on your data ("**Output**"). You may share the Tool with your customers to the extent minimally necessary to explain your Output. You may use your Output for your own internal business purposes only and may publish your Output to external audiences, including, but not limited to, peer review journals, trade groups, and vendors (collectively "**Publications**"); provided, however, that you must identify the Tool in such Publications as originating from HPI using the following attribution:

Upon termination of this Agreement (a) the license granted to you in this Agreement will terminate, (b) you must immediately discontinue the use of the Tool and Content (defined below) and any HPI intellectual property in your possession and control, and (c) you must delete all components, content and materials included in the Tool (collectively "**Content**") in your possession and control.

Neither you nor anyone else has or gets any right, title or interest in or to the Tool other than those granted in this Agreement.
8. Notwithstanding anything hereunder to the contrary, you are not and will not be deemed a licensee of any of our trademarks, service marks, logos or commercial symbols ("**Marks**"). Except as authorized hereunder, you may not use or authorize any others to use any Marks in your business or for any purpose.
9. You hereby consent to HPI's use of your name, logos, trademarks, or trade name in marketing materials, presentations, advertisements, news releases, and other publications regarding your use of the Tool.
10. YOU ACCEPT THE METHODOLOGY AND CONTENT "**AS IS**", WITHOUT WARRANTY OF ANY KIND, AND WE DISCLAIM ANY EXPRESS AND IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR ANY PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT. YOU MUST USE YOUR INDEPENDENT JUDGEMENT ON WHETHER TO USE OR IMPLEMENT THE TOOL. YOU ARE SOLELY RESPONSIBLE FOR YOUR USE OF THE TOOL AND ASSUME ALL RISK IN THE USE OF THE TOOL. You may not assign any of your rights or duties hereunder, (by operation of law, change of control, or otherwise), to any third party without our written consent, and any purported assignment in violation of this provision will be void. If any ambiguity or question of intent arises, this Agreement will be construed as if jointly drafted by the parties and no inference, presumption, or burden of proof will arise favoring or disfavoring either party by virtue of authorship of the provisions of this Agreement. This Agreement constitutes the entire agreement of the parties to this Agreement with respect to the matters provided for in this Agreement. This Agreement may not be amended except by an agreement in writing signed by the parties hereto.
