**Initial Year Service Fees:** HealthPartners will treat the following enrollments as an initial enrollment Member New to Medicare.

- Enrollee is new to Medicare
- Enrollee moves from an employer group plan to an individual plan
- Enrollee qualifies for an SEP enrollment

HealthPartners will treat the following enrollments as Member Transfer from Unlike Product.

- Enrollee moves from a different plan type. Plan changes that are from an unlike product type are:
  - MA or MA-PD plan to Cost or PDP
  - Cost to MA or MA-PD or PDP
  - PDP to MA or MA-PD or Cost

**Renewal Service Fees:** HealthPartners will treat the following enrollments as renewal enrollment in the plan and the renewal rate service fees will be paid:

- Enrollee remains in the plan after the initial year
- Enrollee moves between plans of the same type. Plan changes that are to a plan of the same type are:
  - MA or MA-PD to another MA or MA-PD
  - Cost to another Cost
- 1. Payment recovered: HealthPartners will recover compensation paid under the following circumstances:
  - a. Rapid disenrollment: If an enrollee disenrolls within the first three months of enrollment in the plan, HealthPartners will recover all service fees (monthly and lump sum) it has paid on behalf of that enrollee by withholding the amount already paid from one or more subsequent payments.
  - **b.** Contract Termination: If a member terminates coverage before the end of the calendar year, HealthPartners will recover any service fees for months without active coverage.

HealthPartners will recover compensation by withholding the amount to be recovered from subsequent payments.

- 2. Good standing: Broker must remain in good standing with HealthPartners to receive initial and renewal service fees. Good Standing is defined as maintaining an active sales license, being appointed by HealthPartners, maintaining E & O, and completing annual certification and product training for all HealthPartners Medicare plans they will be representing with a passing score as required by CMS.
- **3. Production Requirements:** HealthPartners reserves the right at our discretion to determine that a minimum number of contracts be written during the first two years after appointment, and may from time to time determine if broker's appointment is still valid by any of a number of different measurements such as production, attendance at training events, broker forums, employer symposiums, meetings with our sales team, etc. HealthPartners will measure production to determine whether the Production Requirement has been met on an annual basis.
- 4. Broker of Record (Agent of Record) Privileges: HealthPartners will recognize Broker of Record transfers of Large and Small Employer Group business to Brokers employed by or contracted with brokerage firms that are subject to this Brokerage Firm Agreement per group AOR guidelines. Non- group or Individual business is eligible for Broker of Record transfers upon the next premium cycle change, which is January 1<sup>st</sup> in most cases. Medicare business is not eligible for agent of record changes.

5. Changes in service fees: HealthPartners reserves the right to change this service fee addendum at any time.
